#### Additional comments on **Challenges**:

It is important to consider that too many assessments, reports and evalution procedures can distract the NCP from its main duties, in particular specific instances handling. This should be taken into consideration by all the actors involved: different stakeholders, the OECD Secretariat and Working party members. The improvement and strengthening of the NCP requires time to implement and develop adjustments.

This is the second year we present this as a challenge.
